

MINUTES OF REGULAR MEETING OF THE CITY COMMISSION
OF THE CITY OF LUFKIN, TEXAS, HELD June 2nd
1942 AT 7:30 P.M.

On this the 2nd day of June, A. D. 1942,
the City Commission of the City of Lufkin, Texas convened in
regular session, in the regular meeting place in said
City, with the following members thereof, to-wit:

being present, and the following absent: None,
constituting a quorum when the following business was transacted:

1. The minutes of all meetings held during the month of May were read and regularly approved.
2. Captain W. E. White of the Texas Defense Guard appeared before the Council and explained that the Guard was in need of funds for purchasing ammunition for rifles they had secured and requested the Council to contribute \$25.00 per month for that purpose and to help defray other expenses.
3. R.E. Melvin made motion, seconded by Cary C. Trevathan that the City contribute \$25.00 per month for Four months to the Texas Defense Guard, provided Angelina County contributes a like amount, all Commissioners voting " Yea " .
4. City Manager Kelley brought up the matter of the City adopting a policy with reference re-employment of City employees who are drafted into or who enter the armed service of the United States during the war.
5. After discussion of the matter, motion was made by Cary C. Trevathan and seconded by R.E. Melvin that the City's policy be to re-employ after the war all employees who enter the service, all commissioners voting " Yea " .
6. Mr. Kelley also brought up the matter of granting City employees ~~vacations~~ and without regular resolution, the expressions of all the commissioners was that vacations be granted as has been the custom here-to-fore.
7. Mr. Kelley reported that he had a request for the NYA for renewal of rent free lease on the Wilson home owned by the City and referred to as the NYA resident center on Denman Avenue but that he expected to have a clearer description of the property shown and a more satisfactory form of lease before recommending action.
8. Bill of \$925.98 in favor of Koch & Fowler, being voucher No. 21 dated May 29th 1942 was presented and recommended by Mr. Kelley for payment.

9. Upon motion by Cary C. Trevathan, seconded by B.F. Milligan all commissioners voting "Yea", the bill was approved and ordered paid.

10. Mr. Kelley reported that he and Mr. Fowler, of Koch & Fowler City Engineers in connection with present Street Paving project, had gone over different matters in connection with the paving being done, especially with reference to the condition of the soil the pavement was being laid on and that he had requested Mr. Fowler to make a written report giving his opinion about the method being followed.

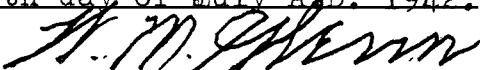
11. Mr. Kelley requested authority for purchasing office furniture and fixtures that were needed and on motion of Cary C. Trevathan, seconded by B.F. Milligan, all commissioners voting "Yea" he was granted authority to purchase such as was needed.

12. Judge Butler Rolston and County Commissioner John Thompson appeared and requested that the City grant additional right-of-way needed for the road through the property owned by the City South of town just outside the City limits and Mr. Kelley was requested to go with Mr. Thompson and look the situation over and make report.

13. Reverend Monroe Vivian and John B. Perry appeared and requested the City furnish some help for supervising the Community Center building in the City park for the next few weeks during the absence of Mr. Corson and Mr. Kelley suggested that he could take care of the matter with present City employees, which was agreeable.

There being no further business to come before the meeting it was adjourned in regular order.
