

MINUTES OF A REGULAR MEETING OF THE CITY
COMMISSION OF THE CITY OF LUFKIN, TEXAS,
HELD ON FEBRUARY 4, 1947 AT 7:30 P. M.

On this, the fourth day of February, 1947, A. D., the City Commission of the
of the City of Lufkin, Texas, convened in a regular session, in the regular
meeting place in said City, with the following members thereof, towit:

being present, with L. C. Martin, Commissioner Ward 4, being absent, thus
constituting a quorum, when the following business was transacted:

Minutes of all meetings held in January, 1947, were read and approved.

1. Mr. H. C. Billingsley, Jr. was present and asked that the City accept a new
Addition that was owned and being developed by him. After some discussion, it
was moved by B. F. Milligan and seconded by D. M. Thrash that the Addition be
accepted, subject to approval of the City Manager and City Engineer. The motion
carried by all members present voting yea.

2. Mr. J. E. Walker requested permission to use concrete pipe for sewer mains in
the Walker Addition to the City of Lufkin. He was told that under the present
rules and regulations that only vetrified clay pipe could be used.

3 Glenn Gamble of the Square Deal Taxi Cab Company, was present and made verbal
application for two additional Taxi Cab permits for his Company. He was told
to file his written application with the City Secretary in order that it might be
advertised for public hearing before the Council.

4 The following Zone change applications were read:
D. O. Wallis--portion of "A" district to "F" district;
W. C. Dempsey--portion of "C" district to "H" district;
Mrs. K. Morgan--portion of "A" district to "B" district;
Trustees of First Methodist Church--portion of "A" district to "B" district.

5 All applications had been previously approved by the Zoning board.

6 After hearing the applications read, it was moved by B. F. Milligan and second-
ed by D. M. Thrash that all applications be advertised for public hearing at a
Called meeting, February 10, 1947 at 3:30 P. M. The motion carried by unanimous
vote of yea.

7. An application for two additional taxi cab permits from Braker Alexander
was read. It was then moved by D. M. Thrash and seconded by B. F. Milligan that
all applications for Taxi Cab Permits now pending, be advertised for public
hearing at a Called meeting of the Council on February 10, 1947 at 3:30 P.M.
The motion carried by unanimous vote of yea.

8 Motion was made by D. M. Thrash and seconded by E. A. Gibbs that no more
applications for additional Taxi Cabs be accepted before July 1, 1947. The motion
carried by all members present voting yea.

9. After a brief discussion, it was moved by D. M. Thrash and seconded by B. F.
Milligan that an ordinance setting a maximum rate to be charged by the Lufkin
Telephone Exchange for service, be passed on second reading. The motion carried
by unanimous vote of yea.

10 Mr. Early reported that he had contacted Mr. J. O. Booker, Engineer, in re-
gards to making a survey of a proposed extension of the City Limits. He stated
that Mr. Booker had made a price of fifty dollars (\$50.00) per mile for making
the survey and that it was his recommendation that he be employed. It was then
moved by B. F. Milligan and seconded by E. A. Gibbs that Mr. Booker be employed
for the job. The motion carried by unanimous vote of yea.

There was no further business presented, so the meeting adjourned.
