- The Commission received application for Zone Change from E. L. Berry and Abe French for change of Zone from "A" District to "H" District on Lots 1,2,3,4 and 5 in Block #3 of the J. S. Moore Addition to the City of Lufkin. On motion of Com. Zeagler, seconded by Com. Nerren All voting "Aye". This application was passed for publication. The Commission also received application from J. E. Walker for change of Zone from "B" District to "G" District on 17.66 acres of land, more or less, situated in the East part of Lufkin, and being a portion of The Walker Addition to the City of Lufkin. On Motion of Com. Nerren Seconded by Com. Stegall, all voting "Aye", this application was passed for publication.
- 3 The Commission granted the C.A.P. location in City Park for the Erection of Building for their use for school, radio station, recreation and other activities. Motion by Com. Nerren, Seconded by Com. Zeagler, all voting "Aye". Except Com. Stegall "No". Motion Carried.
- 4 On Motion of Com. Stegall, seconded by Com. Nerren. All voting "Aye". The Commission granted Arthur Temple, benefit of recent ordinance pertaining to Water lines outside City Limits. This pertaining to water line recently laid on Hwy. 94 for factory use.
- 50n Motion by Com. Zeagler, seconded by Com. Stegall, all voting "Aye." The Commission set distribution of the rate of \$1.75 per \$100.00 value as follows--General Fund \$1.32, interest & Sinking Fund .43¢.
- The Council accepted the proposal of Axley & Rhode for Annual audit for a price of \$40.00 per Diem. Not to exceed \$500.00.
- 7 On Motion of Com. Stegall, Seconded by Com. Zeagler, all voting "Aye". The Commission agreed to try to purchase the Satterfield Property adjoining the present location of Log Cabin Relief Office for futurer location for City Hall Building.
- % The Commission canvased the returns of the April 7, 1953 City Election finding that there were cast, 1437 valid and legal votes. Woodrow W. Scott receiving a mojority for Mayor Elwyn Gipson receiving a mojority for Com. Ward 1, and W. F. (Bill) Collins receiving a majority for Com. Ward 3.
