the following business was transacted:

- 1. The meeting was opened with prayer by Mayor S. R. Parker, Jr.
- 2. The Minutes of the regular meeting of August 19, 1958, were read and approved.
- 3. Mrs. Mabel Jones came before the Commission and protested her water, garbage and sewer bills on her apartment houses. She claimed that her apartment houses should be considered as one unit. She particularly opposed the garbage and sewer charges and said she would not pay same but would pay her water bill on the same basis as heretofore paid. She was told that the City would make no change in the Ordinance regulating water, garbage, and sewer charges.
- 4. The street paving program was discussed. The City Manager was authorized to advertise for bids for the hard-surfacing of certain streets in the City.
- 5. The Commission authorized the payment to East Texas Fence Company for the fencing of the City Warehouse property as per prior contract, in the sum of \$3,516.00.
- 6. An Ordinance annexing the Jack Murphy property to the City of Lufkin was passed on second and final reading.
- 7. A general discussion of the recreational program, was had. The YMCA program was also discussed and how the building might be financed and where it is to be located.
- 8. The City Attorney was instructed to advise whether the City could spend money on the YMCA building.
- 9. The City Manager was authorized to advertise for bids for cleaning,

repairing and the painting of the elevated water tank located on Kurth Drive.

- 10. The short street on the Northside of the Kurth School, running North and South, was named "Standley Street" in honor of Ernest Standley, deceased.
- 11. The old City Park was named "Chambers Park" in honor of Colonel Cal C. Chambers, deceased.
- 12. The City Commission authorized the opening of Second Street from Jody Street to Denman Avenue.
- 13. An Ordinance was passed on first and final reading determining the necessity and providing for improvements on portions of Locke Street, Judith Street and Paul Avenue, in the City of Lufkin.
- 14. There being no further business to come before the Commission, the meeting adjourned.
