## Lufkin, Texas. June 20th., 1914. -

Be it remembered that on this the 20th, day of June A. D. 1914, there came on and was held a "Special" call meeting of the City Council, of the City of Lufkin, in the Council Chembers of said City, there being present and presiding the following officers:

C. N. Humason, Mayor,

A. J. Glenn, Aldermen,

L. H. Gray, City Secretary.

S. H. Kerr,

B. P. Gibson,

T. A. Taylor,

I. D. Pairchild. "

When the following proceedings among others, were had to-wit:

The purpose of the meeting, as explained by the Mayor, being to canvass the returns of the election held in this City on June 13th., and to attend to such other business as may properly come before them.

Upon motion of Alderman Fairchild, seconded by alderman Gibson, all alderman voting age upon the question, the following resolution was adopted:

At a meeting of the City Council of the City of Lufkin, Texas, held on the 20th day of June, A. D. 1914, came on to be considered the returns of an election held on the 13th. day of June, A.D. 1914, to determine whether or not the City of Lufkin, Texas, should take over all property, both real and personal, of the old municipal corporation of the City of Lufkin, Texas, and thereby assume all the indebtedness, contracts and obligations of said old corporation which existed prior to the election held on the 25th. day of March, A. D. 1914 abolishing same, and which said old corporation was succeeded by the present or new corporation of the City of Lufkin, Texas, at an election held for that purpose on the 18th. day of April, A.D.1914, and it appearing that said election was in all respects lawfully held, and said returns duly and legally made, and that there were cast at said election 150 votes, of which number 128 votes were cast "For taking over property," and 22 votes were cast "Against taking over property."

It is therefore ordered and declared that the proposition to take over said property and assume said indebtedness, contracts and obligations was sustained by a majority of the qualified property taxpayers voting at said election, and that all the property, both real and personal, of the old corporation of the City of Lufkin, Texas, as above described, is taken over by and vested in the present municipal corporation of the City of Lufkin, Texas, said corporation thereby assuming all the indebtedness, contracts and obligations of said old corporation.

Mayor appointed the following named gentlemen and citizens of the City of Lufkin to act as a board of Equalization for the City of Lufkin, for the year 1914: S. J. Cowert, W. P. Berry, and O. J. Lang, and that they sit as such board, commencing the first Monday in August next, and continue until their labors are ended.

Communication from C. A. Ricks, manager of the Huntington Herald read, asking permission to run a private telephone line from Huntington into the City of Lufkin, for the benefit of the Herald and it's patrons. Motion prevailed, authored by alderman Kerr, that the City Secretary escertain from Mr. Ricks, exactly what streets he proposes to run his line over, kind of telephones to be used, and whatever other embodiments of his franchise he wished.

There being no further business, a motion was carried to adjourn.
