Moved by Alderman I. D. Fairchild, and seconded by Alderman S. H.
Kerr, that the following ordinance be passed, styled;

AN ORDINANCE AMENDING SECTION 8 OF AN ORDINANCE PASSED BY THE CITY COUNCIL OF THE CITY OF LUPKIN, TEXAS, AND APPROVED BY THE MAYOR ON THE 6TH. DAY OF OCTOBER, A. D. 1914, ENTITLED: "AN ORDIT NANCE AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF THE COUPON BONDS OF THE CITY OF LUFKIN, TEXAS, TO THE AMOUNT OF FORTYVIHOUSAND DOLLARS FOR THE PURPOSE OF CONSTRUCTING, IMPROVING AND EXTENDING THE ROADS, BRIDGES AND STREETS WITHIN THE CITY OF LUFKIN, TEXAS; AUTHOR-IZING AND PROVIDING FOR THE ISSUANCE OF THE COUPON BONDS OF THE GITY OF LUFKIN, TEXAS, TO THE AMOUNT OF TWENTY FIVE THOUSAND DOLLARS, FOR THE PURPOSE OF IMPROVING AND EXTENDING THE WATER WORKS SYSTEM ISSUANCE OF THE COUPON BONDS OF THE CITY OF LUFKIN, TEXAS, TO THE AMOUNT OF TEN THOUSAND DOLLARS, FOR THE PURPOSE OF IMPROVING AND EXTENDING THE FIRE DEPARTMENT OF THE CITY OF LUFKIN, TEXAS, WITHIN ITS LIMITS; AND PROVIDING FOR THE COLLECTION OF A TAX TO PAY THE INTEREST AND CREATE A SINKING FUND FOR THE REDEMPTION OF BAID BONDS AT MATURITY"

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LUFKIN, TEXAS:

SECTION I. That Section 8 of an ordinance passed by the City Council of the City of Lufkin, Texas, and approved by the Mayor on the 6th. day of October, A.D. 1914, entitled: "An ordinance authorizing and providing for the issuance of the coupon bends of the City of Lufkin, Texas to the amount of forty thousand dollars for the purpose of constructing, improving and extending the roads, bridges and streets within the City of Lufkin, Texas; Authorizing and providing for the issuance of the coupon bends of the City of Lufkin, Texas, to the amount of twenty five thousand dollars for the purpose of improving and extending the water works system of the City of Lufkin, Texas; and authorizing and providing for the issuance of the coupon bends of the City of Lufkin, Texas, to the amount of the thousand dollars for the purpose of improving and extending the fire department of the City of Lufkin, Texas, within its limits; and providing for the least and collection of actax to pay the interest and create a sinking fund for the redemption of said bonds at maturity", be amended so as to hereafter read as follows:
