Motion by alderman Gibson, seconded by alderman Fairchild, all alderman voting aye, that the following ordinance, styled, "AN ORDINANCE ESPABLISHING SANITARY DISTRICT NO. 1, AND PROVIDING FOR THE ABOLISHMENT OF SURFACE CLOSETS, UNLESS CONNECTED WITH SEWER SYSTEM, IN SAID DISTRICT; ALSO PROVIDING FOR ABOLISHMENT OF SURFACE CLOSETS USED IN CONNECTION WITH HOTELS, BOARDING HOUSES. ROOMINE HOUSES, AND PUBLIC BUILDINGS, WITHTN THE CITY OF LUFKIN, TEXAS, AND PROVIDING FOR COMPULSORY CONNECTION WITH SEWER SYSTEM OF ALL SUCH PROPERTY OR PREMISES, IN CONNECTION WITH WHICH CLOSETS ARE USED, WHEN SAME ARE WITHIN 200 FEET OF LINE OF SEWER SYSTEM; AND PROVIDING PENALTIES" be passed and approved, and the same is hereby passed and approved.
