MINUTES OF A CALL MEETING OF THE
CITY COMMISSION OF THE CITY
OF LUFKIN, TEXAS; HELD
Nov. 15th, 1926.

Be it remembered that on this the 15th day of November, A.D. 1926, there came on and was held a joint meeting of the City Commission of the City of Lufkin, Texas, and the Commissioners' Court of the County of Angelina, at the City Hall in said City, with the following members of the City Commission present; J.W. Hawkins, Mayor, Joe C. Denman, Commissioner of Ward No. 1, A. M. Walker, Commissioner of Ward No. 2, W.A. Behannon, Commissioner of Ward No. 3, E. W. Leach, Commissioner of Ward No. 4, V. R. Smitham, City Manager, W. C. Seale City Attorney and T.E. Dunn, City Secretary, and the following members of the County Commissioners' Court also present: R. A. Courtney, County Judge, V. V. Crocker, County Commissioner of Precinct No. 1, J. W. Allen, County Commissioner of Precinct No. 2, J. L. Treadwell, County Commissioner of Precinct No. 3 and J. W. Lock, County Commissioner of Precinct No. 4, when the following proceedings were had, to-wit:-

The purpose of the meeting was receive and open bids heretofore advertised for, for the paving and improving of the Angelina Court House square.

The following is a list of the bidders and the amount each bid:-

Brown & Root, Houston, Texas-----	19,593.39
J. S. Moore & Sons, Lufkin, Texas---	20,907.95
D. B. Taliaferro, Tyler, Texas-----	19,280.12
R. J. Shearer, Lufkin, Texas-----	19,991.65
Dallas Paving & Road Co, Ft. Worth-	20,871.18

After receiving and opening of the above bids, and after due and deliberate consideration of same, the Commissioners' Court of Angelina County, first took action on same, as follows: Moved by J. L. Treadwell and seconded by J. W. Locke that the bid of Reynolds & Sutton of Tyler, Texas, be accepted and the contract awarded to them. Said motion having been put to a vote, the following members of said Commissioners' Court voted in favor of same, V.V. Crocker, J.W. Allen, J.L. Treadwell and J.W. Lock. There were no votes against same, whereupon the County Judge declared the motion carried and the contract awarded to the said Reynolds & Sutton. The City Commission of the City of Lufkin, Texas, took action on the matter as follows:- A. M. Walker made a motion which was seconded by W. A. Behannon that the bid of Reynolds & Sutton of Tyler.

Texas, be accepted and that the contract be awarded to them. Said motion having been put to a vote by the Mayor, the following members of the City Commission voted in favor of said motion, J.W. Hawkin, Joe C. Denman, A. M. Walker, W.A. Behannon, and E.W. Leach. No votes were against the motion, whereupon the Mayor declared the motion carried and the contract awarded to the said Reynolds & Sutton. The work to be completed in sixty (60) working days.

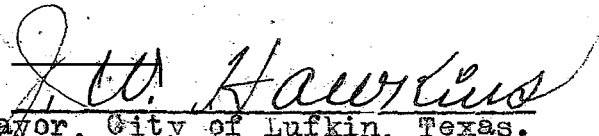
It being thought that in connection with the improvements outlined above that it would be necessary to construct some six inch concrete pavement, and also that other six inch pavement might be considered, in order to be prepared for such without having to advertise for additional bids for the construction of same, an alternate bid was asked for from each of the bidders above named, covering six inch concrete pavement, and the following bids were submitted:- Joe McCarthy, \$2.80 per square yard; Reynolds & Sutton, \$2.55 per square yard; Brown & Root, \$2.70 per square yard; J.S. Moore & Sons, \$2.80 per square yard; D. B. Taliaferro, \$2.60 per square yard; R. J. Shearer, \$2.60 per square yard and Dallas Paving & Road Co. \$2.71 per square yard.

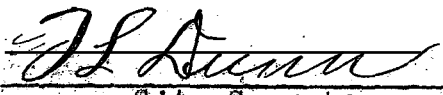
There being no further business to come before the meeting on motion duly made and carried said adjourned.
