Bremond Avenue from the East Line of North Angelina Avenue to the Wwat line of North Third Street.

E. J. Conn appeared and asked that a gas franchise be granted to a local company on the same conditions and at the same rates as those demanded by the Dixie Gas & Fuel Company. He proposed to post a bond in the amount of \$20,000.00, guaranted ing to furnish gas in a specified time. After discussing the question it was unanimously decided to refuse to grant such a franchise.
