MINUTES OF A CALL MEETING OF
THE CITY COMMISSION OF THE CITY OF LUF-
KIN, TEXAS, HELD JAN. 15th, 1929.

On this the 15th day of January, A.D. 1929, the City Commission of the City of Lufkin, Texas, met in called session at the City Hall in said City with the following members and officers present, to-wit: J. W. Hawkins, Mayor presiding, Joe C. Denman, Commissioner of Ward No. 1, G. A. Burke, Commissioner of Ward No. 2, M. C. Spivey, Commissioner of Ward No. 3, W. A. Abney, Commissioner of Ward No. 4, V. R. Smitham, City Manager, W. O. Seale, City Attorney and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

The Mayor stated that the purpose of the meeting was to accept certain streets as being completed under paving contract with Scott Shambaugh, and to do and perform any other matter as might properly come before the body.

Mr. H. C. Rich appeared before the Commission and made a request that a certain alley in Block No. 45 of the Denman Addition, and being that portion of said alley connecting Denman Avenue and Charlton Street, be deeded to him in consideration of him assuming the cost of paving on Charlton Street directly in front of said Alley. After due consideration of the matter it was moved by Commissioner G. A. Burke and seconded by Commissioner W. A. Abney that said portion of said alley as aforesaid be deeded to the said H. C. Rich by Quit-Claim Deed on condition and in consideration of him the said H C Rich assuming the City's part of the cost of paving Charlton Street directly in front of said Alley. The motion carried unanimously, and the City Attorney was instructed to prepare deed and the Mayor is hereby authorized to execute same in the name of the City.

The matter of deeding that part of or plot of land heretofore deeded to the City by the County, and being ³⁸80 feet in width all along the East Side of the Court House, was discussed and it appearing that the property owners part of the cost of paving third street adjacent thereto is to be assumed and paid by the County, that it would be proper for the title to said strip of land to be in the said County. It was therefore moved by W. A. Abney and seconded by M. C. Spivey that the City make proper deed of conveyance to Angelina County covering the said strip of land as above described, and the Mayor be authorized to execute deed in the name of the

City conveying same. Said motion carried unanimously, and the City Attorney is hereby instructed to prepare proper deed of conveyance as aforesaid.

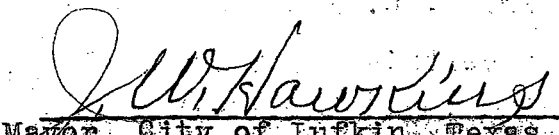
The City Engineer having reported the completion according to contract with Scott Shambaugh of the paving of Conn Avenue from its intersection with east line of Denman Avenue to its intersection with east line of Moody Street; and Pershing Avenue from its intersection with west line of South First Street to its intersection with ^{East} ~~west~~ line of South Raguet Street, and he having recommended that same be accepted by the City, on motion made by M. C. Spivey and seconded by C. A. Burke, it was unanimously carried that said streets be accepted.
