MINUTES OF REGULAR MEETING OF THE
CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
HELD OCTOBER 2nd, 1934.

Be it remembered that on this the 2nd day of October, A.D. 1934,
there was begun and holden a regular meeting of the City Commission of
the City of Lufkin, Texas, at the Municipal Office in said City, with
the following officers of the City present and presiding, to-wit:-

The following proceedings were had, to-wit:-

Minutes of all meetings held during the month of September, 1934,
were read, and on motion duly made and carried were approved as read.

City Health Officer,

A report from Dr. R.T. Canon, was read to the City Commission
and on motion duly made and carried was was accepted and approved.

An ordinance entitled "An Ordinance to provide for the construction,
maintenance, inspection, and operation of privies in the City of Lufkin,
Texas, and area of police jurisdiction thereof; and to provide a penalty
for the violation of said ordinance, or any section there" was intro-
duced for passage and approval on first reading. Louis Hicks made a
motion that said ordinance be read and that it pass first reading. W.O.
Greene seconded the motion. The Mayor put the question and the following
is the recorded vote on the motion: "Ayes"- C.A.Burke, W.O. Greene, Louis
Hicks, D.A. Campbell and W.A. Abney. "Noes"- None. Whereupon the Mayor
declared the said motion carried and the said ordinance passed and ap-
proved on first reading.

Representatives of the U.S.Forest Service request again that the
city grant to them a lease for a period of twelve months on the J.E.
Wilson Building located at 44 Denman Avenue, which said building is
owned by the City of Lufkin. After again considering the question it
was moved by W.O. Greene that a lease for 12 months be given to the
U.S.Forest Service at a price of \$50.00 per month, date of lease to
begin with July 6th, 1934, the date the building was moved into and
began to be used by the U.S.Service as an office building. The motion
was seconded by Louis Hicks. The Mayor put the question and the motion
carried by a unanimous vote.

RESOLUTION PROVIDING FOR DISCOUNT
ON 1934 CITY TAXES.

Whereas, the City Manager has made written recommendatin that certain discounts be allowed tax ~~payers~~ on the 1934 taxes due, and

Whereas the City Commission is desirous of extending the relæf provided by allowing such discounts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LUFKIN:

(1) That in the payment of current (1934) City Advalorem Taxes, that if payment is made any date during the month of October, 1934, a discount of 5% be ~~allowed~~ on the total amount due; that if such advalorem taxes are paid during the month of November, 1934, a discount of 3% be allowed on the total amount due; that if such advalorem taxes are paid during the month of December, 1934, a discount of 2% be allowed on the total amount due; That if such advalorem taxes are paid during the month of January, 1935, a discount of 1% be allowed on the total amount due.

(2) That any City Advalorem Taxes that have not been paid prior to February 1st, 1935, which were levied for the year 1934, be declared delinquent, and payment therefor thereafter shall be as follows: That if said taxes are paid any date in February 1935, a penalty of 1% shall be added to the total amount due, and that the usual 6% interest also shall be added, such interest to be calculated from February 1st, 1935, until paid, on a per annum basis, and that \$1.00 per year shall also be added for costs; that the amount of the penalty shall be increased 1% per month until the full penalty of 10% is reached.

Passed and approved by a unanimous vote of the City Commission this the 2nd day of October, 1935.
