The matter of the purchase from J. W. Shotwell of the North one-half of Lot No. 6 in Block No. 22 was again discussed, after which it was decided that the city should purchase same at a price of \$875.00 and to pay the cost of an Abstract of said property, with the understanding that the said J. W. Shotwell would pay all taxes due on all property known as the U.M. Brown property, including the taxes on lots 23 and 22 of Block No. 16 and the brick building loctaed tehereon.

B. L. Zeagler owner and operator of the Zeagler Saw Mill made requitsition throught the Mayor for a special officers Commission to be issued to J. W. Cahmablee, an employee, (Night Watchman) of said Zeagler Saw Mill in order that he might have official recogniction and power to see that all lawas of the Gity and State are complied with in the vicintiy of the said saw mill community. On mothion by D.A. Campbell, seconded by W. A. Abney it was unanimously carried that $\sharp/\sharp \not a \not d$ the City Manager should grant the issueance of such special officers Commission as asked for. The City Manager was instructed to notify B.L.Zeagler that his request had been granted and for him to have his man, Mr $\not s$ J.W. Chamblee report to the ^City Hall for purpose of qualifying as such special officer.

The matter again was brought to attention of the City Commission by the Mayor that R.C.Chancey, Chief Police, had not returned to Red Johnson pistol he had heretofore been instructed to return. The City Manager was instructed to instruct the said R.C.Chancey to either return the pistol to the said Red Johnson or to resign his position as Chief Police of the City of Lufkin, Texas.
