3. <u>PUBLIC HEARING ON THE PROPOSED TAX RATE FOR FISCAL YEAR 2013-</u> 2014

Mayor Bob Brown stated that Item No. 3 was to conduct a Public Hearing on the Proposed Tax Rate for Fiscal Year 2013 – 2014.

City Manager Paul Parker stated the City's present tax rate was 0.5038 per \$100 valuation and was divided into two portions; with 0.3338 being designated for maintenance and operations, and 0.1700 for debt retirement. City Manager Parker furthered that the tax rate in the proposed in the 2013-2014 Annual Budget was 0.5038 or the existing tax rate and will also consist of 0.3338 for maintenance and operations and 0.1700 for debt retirement. City Manager Parker stated the effective tax rate was 0.502078; therefore, the proposed tax rate was approximately 0.0017 above the effective tax rate. City Manager Parker concluded that Staff recommended City Council conduct the required Public Hearing regarding the proposed tax rate for Fiscal Year 2013-2014.
